BIO DIESEL COMPANY TO INVEST \$10 MILLION IN NEW ESTILL FACILITY Ecogy Biofuels Will Create 15 Jobs in Hampton County

A new biodiesel company in Estill, South Carolina will help change the way America produces energy.

Ecogy Biofuels will construct a multi-million dollar facility that will produce up to 30 million gallons of biodiesel per year and provide 15 jobs in Estill, South Carolina.

"Our company has international expertise, and we were impressed by all that Estill, Hampton County and the State of South Carolina had to offer," said Dr. Hal Wrigley, President of Knightsbridge Biofuels and Ecogy Biofuels. "Due to support from

Southern Carolina Alliance, Hampton County, the S.C. Department of Commerce, the city of Estill and other local resources, this area will become a shining example of alternative energy solutions."

According to Dr. Wrigley, several factors encouraged Ecogy Biofuels to locate in Estill. First, Estill and South Carolina are committed to training their highly skilled workforce and supporting local economic growth, which will ensure that the state remains competitive. Second, local soybean farmers have been supportive of Carolina Soya for many years. Third, Estill has an excellent rail sys-

tem, as well as close proximity to the ports of Charleston and Savannah.

"For so many reasons, the partnership between our company and the local area will be a winning one," Wrigley said.

"Renewable fuels are good for the economy, good for the environment, and good for national security," said S.C. Commissioner of Agriculture Hugh Weathers, who spoke at the announcement ceremonies held at the Carolina Soya compound. "Cooperative efforts like this can help our state and nation win the war for energy independence while fueling agriculture, a significant economic engine for this state. I welcome Ecogy Biofuels to South Carolina's agribusiness family."

In addition to Commissioner Weathers, several statewide and local officials, including Congressman Joe Wilson, were in attendance at the groundbreaking ceremonies in Estill to demonstrate their support for the project, which will create jobs and more than \$10 million in capital investment in the rural county.

"The people of Hampton County have a great tradition of success in agribusiness, as well as a grand entrepreneurial spirit. Ecogy Biofuels is the type of project that will not only bring jobs to this region, but will also make Estill the home of cutting edge technology in the alternative fuels industry," said Congressman Joe Wilson. "We welcome Ecogy Biofuels and congratulate the people of the Southern Carolina region on landing this important project for the community."

"We have worked closely with Knightsbridge Biofuels, Carolina Soya, the Department of Commerce and the leaders of Hampton County over the last few months to facilitate this project. We believe that Ecogy Biofuels will prove that the evolution of agribusiness can be profitable to both industry and to the community," said Southern Carolina Alliance Board Director Carl Gooding. "Rural communities like ours can flourish by recruiting and fostering innovative technology such as alternative energy production while demonstrating that we can compete globally for industry."

"Knightsbridge Biofuels and Ecogy Biofuels are committed to making this facility a world-class model that will demonstrate that

biodiesel is the best choice as an alternative fuel not only in the future, but also as a commercial solution today," added Wrigley.

"The South Carolina Farm Bureau Marketing Association is proud to be associated with this project," said David Winkles, Farm Bureau President. "As one of the three main investors managing Carolina Soya, the addition of a biodiesel facility was a win-win situation. Carolina Soya is one of the top 100 businesses in South Carolina and we look forward to continued growth as we help Americans reduce our dependence on foreign sources of oil."

"We welcome Ecogy Biofuels," said Hampton Economic Development Commission Chairman William Small, "and we are proud that Hampton County has been chosen as the home to this alternative fuel facility, which will combine our rich history of agricultural products with cutting edge technology."

Ecogy Biofuels will be located on an integrated campus with Carolina Soya, which includes the existing soybean processing facility, a newly constructed soybean oil refinery and the biodiesel production facility.

Carolina Soya will provide the soybean oil for Ecogy Biofuels. Being located together will ensure significant savings for both companies. In addition, a new state-of-the-art steam-generation plant will supply the three entities with steam and provide significant energy savings.

Costs for construction, testing and initial operations of the biodiesel facility will exceed \$10 million. The facility also will house a complete research and testing laboratory that will support not only biodiesel production, but also the other entities on campus.

15 full-time personnel will be employed once the plant becomes fully operational, in addition to the shared employees with Carolina Soya who will assist in operations. Local residents will be trained and employed whenever possible.

"This announcement is another positive sign that our efforts to improve the soil conditions for business are working to create more new jobs and opportunity in rural South Carolina," said Governor Mark Sanford.



State and local leaders celebrate ground breaking for Ecogy Biofuels

S.C. Advanced Technology Park In Snelling Selected for DOE's GNEP Siting Study

The U.S. Department of Energy (DOE) has announced that over \$10 million will be used for 11 commercial and public consortia selected to conduct detailed siting studies for integrated spent fuel recycling facilities under President Bush's Global Nuclear Energy Partnership (GNEP).

"These facilities will enable us to effectively recycle spent nuclear fuel in a safe and proliferation resistant manner. They will set the technological standard and allow us to influence energy policy abroad while increasing energy security here at home," DOE Assistant Secretary for Nuclear Energy Dennis Spurgeon said. "With the negotiations complete, we are ready to proceed from an initial phase to one where actual studies can explore sites for GNEP-related facilities."

Award recipients, announced in November 2006, will carry out

siting studies to determine the possibility of hosting an advanced nuclear fuel recycling center and/or an advanced recycling reactor.

"Our position has been that we have one of the top sites in the country, and we are even more optimistic since we have been selected for the project siting study," said SCA President Danny Black. "The GNEP project could mean more than \$10 billion in capital investment and 5,000 jobs for our region."

Recipients will conduct detailed site characterization studies of the sites which were proposed in their Funding Opportunity Announcement (FOA) responses. Recipients will have 90-days to complete these studies and submit a Site Characterization Report to DOE on May 30, 2007.

Of the 11 sites, six are currently owned and operated by DOE.

Bamberg Receives Housing Funds

The S.C. Department of Commerce has awarded Bamberg with a Community Development Block Grant of \$355,000 for housing rehabilitation on Broad Street and Elm Street. The money will be used to alleviate sub-standard housing and blight in these low- to moderate-income neighborhoods.

Statewide, about \$11.5 million in Community Development Block Grants have been awarded to 28 projects, which will directly benefit more than 18,500 low- to moderate-income people throughout the state.

CDBG projects are selected through a statewide competitive process. Local governments submitted grant applications to the S.C. Department of Commerce, which administers the U.S. Department of Housing and Urban Development grants. Local governments are responsible for providing matching funds of five to 10 percent.

GNEP Educational Forums

Most Successful in the Nation

SouthernCarolina Alliance and Energy Solutions, our corporate partner in the Global Nuclear Energy Partnership project, held educational forums across the region in April as part of the GNEP project site study. The collaboration between the Alliance and Energy Solutions resulted in a record number of participants for the educational forums, which were held April 17-19 in Yemassee, New Ellenton, and Barnwell. More than 250 citizens turned out to learn more about the GNEP program, which could bring more than \$10 million in economic development and 5,000 jobs to the region.

“We were so pleased with the interest our community demonstrated in learning more about the GNEP process and our corporate partner, Energy Solutions,” said Alliance President Danny Black.

“Not only did we have outstanding attendance at the forums, we received overwhelmingly supportive comments from the participants,” added SCA Chairman Kay Still.

The public educational forums are part of the GNEP siting process required by the Department of Energy. The forums were moderated by Stephen Hale of HaleStorm Communications and were led by SCA Alliance President Danny Black and Energy Solutions’ Alan Dobson, Senior Vice President for Fuel Cycle and Spent Fuel Management.

Mr. Dobson provided an informative overview of the GNEP process and Energy Solutions’ experience in the nuclear industry. Rich Smalley, Energy Solution’s Project Manager for the GNEP Barnwell Site, also participated in the educational program, which included hand out materials and a visual presentation prepared by Energy Solutions and SouthernCarolina Alliance. Both Smalley and Dobson answered questions from forum participants at each of the hearings.

“Our community is comprised of generations who have worked in the nuclear industry at SRS, so we understand the benefits of this project and fully support it,” said Black. “Our workforce is skilled in this industry and capable of handling a project of this magnitude.”

Through a new partnership arrangement with SouthernCarolina Alliance, Clemson University has assigned Harry Crissy as a County Extension Economic Development Agent for the SouthernCarolina region.

REGIONAL STUDY AND PLANNING UNDERWAY

Four Counties to Benefit from Economic Development Project

Allendale, Bamberg, Barnwell and Hampton Counties, which comprise the SouthernCarolina region of South Carolina, will benefit from an intense, six-month long regional economic development assessment and planning effort by SouthernCarolina Alliance.

The project, made possible with financial assistance from the South Carolina Power Team, Santee Cooper and the state's 20 electric cooperatives, will include county and regional economic development strategic planning, target industry studies and development of an economic development marketing plan.

"Thanks to the foresight of these utility partners, we have the opportunity to work with some of the country's leading economic development experts in evaluating our area's assets and planning for future economic development and industrial recruitment," said SouthernCarolina Alliance CEO Danny Black.

Black said that the nationally renowned consulting team of Wadley-Donovan Group, Garnet Consulting, and Development Counselors International (DCI) has been selected to conduct the three-phase project.

"This team includes some of the premier consultants in

economic development, marketing, and industrial site location," said Black. "They will be working with our local industrial leaders, as well as statewide leaders such as the S.C. Secretary of Commerce and our state's utility and industry executives to evaluate and assist in planning for future development of our four-county area."

Black added that while SouthernCarolina Alliance continues to focus on industrial recruitment, such as the Kronotex and Grant facilities landed over the last few years, economic development is dependent upon product and community development and marketing.

"More importantly, about eighty percent of new jobs are generated by existing industry in any community," said Black, "so it's critical that we have the input of our local industries in planning for the future."

The project will include public meetings to receive input from the community, as well as individual interviews with local industry leaders. Industry surveys and interviews related to the strategic planning and target industry phases begin this month. The study should be completed in September.

Workforce Initiative

Through a special workforce development grant, supported by our area's colleges and technical schools, our local industries and SouthernCarolina Alliance, members of the workforce in Allendale, Bamberg, Barnwell and Hampton Counties can now be certified and trained for WorkKeys® at no cost.

The Workforce Development Skills Gap Closure Grant has been awarded to our region to assist in preparing our workforce for local and prospective industrial employment opportunities. SouthernCarolina Alliance partnered with USC-Salkehatchie, Denmark Technical College, Allendale SCOOTER-LRTA, Adult Education Centers, ESC-One Stop Centers, and the Rural Crossroads Institute of the S.C. Department of Commerce to secure and implement the grant for our area.

The WorkKeys® System is a job skills assessment test measuring real world skills and is commonly used as a metric to connect employers with job seekers.

According to SCA President Danny Black, in a recent study commissioned by The Palmetto Institute, some employers have expressed a preference for a job-seeker's possession of a WorkKeys® "card" over a high school diploma because employers recognize that a WorkKeys®-assessed job candidate has demonstrated the ability to perform at a prescribed functional or technical level.

"We are fortunate to have this opportunity," said Black. "We will work with the appropriate local and state partners to certify our workforce in the WorkKeys® System to better serve our local industries in their ongoing and expansion needs, as well as our incoming industries."

Those who qualify for the program include area high school seniors, dislocated workers, incumbent workers, high school drop outs, the underemployed and the unemployed.


